

EPWORTH TOWN COUNCIL

Minutes of a Meeting of the Full Council **held on Tuesday, 5th April 2022, at 7.00 pm,** **in the Small Room of the Imperial Hall, Chapel Street, Epworth**

Public Participation

Mr Graham Milnes spoke about Turbary Road. He said back in 2009 the town council saw the need to liaise with the Turbary residents to try and find a solution to Turbary Road. A working group was formed, who concluded that this would be best fulfilled by tarmacing the surface. Quotes were obtained to tarmac the full length of the road and the town council precepted £16,000 to do so. North Lincolnshire Council would not adopt Turbary Road unless it was brought up to highway standard and a figure of £250,000 was mentioned. However at a meeting held on 24th February 2010 between North Lincolnshire Council and Epworth Town Council, it was suggested that if the land could be proven to be in the ownership of the town council then it could surface the road, otherwise the expenditure would be open to challenge, therefore the town council needed to prove land ownership first which would then give it a power to upgrade the surface, and then have an agreement with North Lincolnshire Council about future maintenance. He stated that in a report dated July 2011, an independent barrister appointed by the town council to establish ownership of Turbary Road concluded that it owned Turbary Road and was therefore entitled to carry out work so it was in a reasonable condition for the traffic it carried. However North Lincolnshire Council would then not allow the road to be tarmaced, so a compromise was reached where the surface would be scraped and planings added on a regular basis at the expense of North Lincolnshire Council and Epworth Town Council. Mr Milnes said seven years later given the £2,000 spent on the barrister's report and the £14,000 on road maintenance, the amount set aside in the precept of £16,000 to tarmac the surface had now been spent and we were back to square one. Residents had been told by North Lincolnshire Council that it was illegal to drive on Turbary Road, and also informed by Epworth Town Council that North Lincolnshire Council had taken over it, however he believed the town council still had responsibility for looking after it. He therefore urged the town council to resurrect the working group and try and work with the residents and North Lincolnshire Council to find some form of permanent solution to Turbary Road.

01/04/22 **Record of Members Present**

The following councillors were present: Councillors J Whittaker (Chairman), Brumby, Finch, Fleet, Garner, R Whittaker & Woods.

02/04/22 **Apologies for Absence**

There were apologies from Councillors Cooper - other commitments, and Councillors Stewart - who was going away.

03/04/22 **Declarations of Interest & Dispensations**

- (i) No declarations of interest were made.
- (ii) No dispensations had been granted.

The Chairman suggested that Item 8 (ii) a) Mr G Milnes - Turbary Road on the agenda should be brought forward given there were some residents of the Turbary present. Proposed by Councillor J Whittaker and seconded by Councillor Brumby - It was resolved that this item be brought forward for discussion.

08/04/22 **Correspondence**

(ii) a) Mr G Milnes - Turbary Road. The Chairman explained to councillors some of the history to do with Turbary Road as they were relatively new.

He reiterated some of what had been said by Mr Milnes, that initially £16,000 had been set aside in the precept for the road to be tarmaced and then later a compromise was reached whereby both Epworth Town Council and North Lincolnshire Council made a contribution of £1,000 each per year towards the maintenance of Turbary Road. He believed this agreement was working well for all parties, only for North Lincolnshire Council later not want to continue with the match funding, and therefore withdraw from the arrangement. He then referred to a ward councillor's report which stated that North Lincolnshire Council had taken responsibility for the maintenance the road and any queries from residents should therefore be directed to North Lincolnshire Council's contact centre. However it would appear from communication the town council had received that some residents were not satisfied with the way it was being maintained. He believed the problem was and still is that North Lincs Council has the final say over the character of the path, and if North Lincolnshire Council would not allow a suitable alteration to the surface of the footpath / road, then the town council was in no position to risk taxpayers money by increasing liability. He wanted nothing more than Epworth Town Council to engage in constructive, transparent meaningful communication to find a solution to the ongoing issue. He encouraged residents to lobby their ward councillors and request their support in getting North Lincs Council to re-engage with all stakeholders to find a suitable solution for the future.

Proposed by J Whittaker and seconded by Councillor Brumby - **It was resolved that standing orders be suspended temporarily to allow a member of the public to speak.**

Mr Milnes informed the Council that they had been lobbying their ward councillors and the next step was to go to the MP to see if he could help. He reiterated the need for a working group to meet up with North Lincolnshire Council who he said were only looking at it as a footpath despite it being terrible to walk down.

Proposed by Councillor J Whittaker and seconded by Councillor D Woods - **It was resolved that the Council should support the residents by approaching North Lincolnshire Council along with the ward councillors and ask for a meeting with all interested parties (including residents) to try and find a solution to the problem of Turbary Road.**

04/04/22

Chairman's Report

(i) End of Chairmanship - The Chairman told councillors it would be his last meeting as Chair and how proud he had been to represent the Council. He didn't think the Council would undergo the amount of change it had and the amount of work it involved. He had tried as hard as he could possibly do in the role to drive change. He thanked councillors for the work they had done in the last three years, which needed to continue in the future. **(ii) Epworth & Belton Scout Group** - He had met the Leader and the Scouts, however he needed more support, therefore he asked councillors if they knew anyone. **(iii) Epworth Sharks Swimming Club** - Struggling for swimmers, so again he asked councillors if they knew of any kids or adults who would be interested. **(iv) Consultation** - He believed this had been a success with many residents attending to chat about the development and other issues. **(v) Hanging Baskets** - He had helped Councillor R Whittaker sort out the hanging baskets and thanked her for this. Proposed by Councillor Brumby and seconded by Councillor R Whittaker - **It was resolved that the report be noted.**

05/04/22

Ward Councillors' Report

(i) **Highways Issues** - M180 junction now open, Goodcop Pumping Station bridge repair is complete and Thorne Road just outside of Sandtoft is open. Yorkshire Water have a daytime road closure on the Wroot Road - this is for major repairs scheduled until June. Northern Powergrid are continuing the major electrical cable laying and substation upgrades between Epworth and Haxey. Start of a major programme of footpath refurbishment in Epworth - Woodland Way and Pinfold. Recently requested that the footpaths running alongside Epworth Primary school be inspected and action taken to improve the path surface and cut back further to reduce them being overgrown.

(ii) **Community Payback** - Ideas submitted but the Probation Service have said they can't travel with their offenders due to their own COVID restrictions.

(iii) **Planning** - Both ward councillors attended one of the consultation events for the Millea Land Developments proposals for the Epworth Garden Centre site, whilst it was good to see developers wanting to invest in the town, they have a huge number of concerns around the proposals and await a planning application.

(iv) **Bus Services** - Isle Coaches have given notice to the Traffic Commissioners for Great Britain and North Lincolnshire Council that they will no longer operate with effect from June this year and Hornsby's will take over the routes.

(v) **5G Phone Mast and Cabinets on Tottermire Lane / Belton Road** - The Leader of North Lincolnshire Council and Councillor Mitchell had met with a senior representative from mobile phone company Three UK and asked them to take action to address the appearance of the equipment at this location - including painting the cabinets green and moving the bench and planters now blighted by the installation. He stated that this was feasible and they would consider the requests, however there had been no response to date.

(vi) **Household Waste Collections** - The past two weeks have seen the service badly affected by driver absence due to COVID. Let them know if any residents haven't had their bins emptied and they'll ensure that the crew re-attend. Residents waiting for bin exchanges are having to wait a long time as the service focusses on the household waste collections during the staffing issue.

(vii) **Men In Sheds** - 27th April 2022 and 25th May 2022. Drop in information sessions at the Imperial Hall in Epworth. An initiative aimed at reducing loneliness and social isolation in men - although not exclusively men.

(viii) **NHS Digital** - Information sessions at various church coffee morning in Epworth and Belton aimed at helping older residents become familiar with NHS Apps. The project team will also help residents with smart technology in general - again helping them to stay connected and reduce feelings of social isolation. Proposed by Councillor Finch and seconded by Councillor Woods - **It was resolved that the report be noted.**

Queen's Platinum Jubilee Celebrations

(i) Advertisement of Musical Events on New Waste Bins - At a meeting of the Combined Cemetery & Environment Committee held on Wednesday, 23rd March 2022, it discussed whether to advertise the Ceilidh and Miss Marina Mae Concert on the new waste bins. Proposed by Councillor Woods and seconded by Councillor Finch - **It was resolved that Full Council should agree with the recommendation made by the Combined Cemetery & Environment Committee to advertise the musical events being held in Epworth for the Queen's Platinum Jubilee celebrations on the new North Lincolnshire Council Waste Bins.**

(ii) Food Fair - At a meeting of the Combined Cemetery & Environment Committee held on Wednesday, 23rd March 2022, it discussed if the small area at the back of the Kings Head Croft car park could be used by food / drink vendors. Proposed by Councillor Woods and seconded by Councillor Finch - **It was resolved that Full Council should agree with the recommendation made by the Combined Cemetery & Environment Committee to see if the small area at the back of the Kings Head Croft car park could be used by food / drink vendors on Sunday, 5th June 2022, from 11.00 am to 4.00 pm - subject to North Lincolnshire Council permitting it.**

(iii) Beacon - At a meeting of the Combined Cemetery & Environment Committee held on Wednesday, 23rd March 2022, it discussed the possibility of a need for the Beacon to be moved. Proposed by Councillor Finch and seconded by Councillor Garner - **It was resolved that Full Council should agree with the recommendation made by the Combined Cemetery & Environment Committee to ask North Lincolnshire Council if the Beacon**

could be moved from its existing location to the edge of some land they own off Belton Road - however this was subject to it not being able to stay where it is now and informing the landowner we were trying to get it moved.

Waste Bins

(i) **General Waste Bins** - The Clerk had received an email from one of the ward councillors about the waste bin consultation and provided each councillor with a copy of it. The Council had asked for the following bins:- a) The floor bin at the top of Hollingsworth Lane to be moved to Fieldside, however it would have to pay for it to be repositioned. b) A post bin to be provided near the sewage pumping station near Hollingsworth Lane, but was told that post bins are not routinely being fitted. c) A floor bin to be provided outside Oceans 52, and was told a bin would be provided but further down nearer South Axholme Group Practice. d) A post bin to be provided outside the HSBC Bank in the Market Place, and was told a floor bin would be provided. One of the ward councillors commented that the old unsightly town centre bins would be replaced with larger capacity bins with recycling provision and be conservation suitable. Councillors welcomed the consultation over where the waste bins would go, but some would have liked to have been consulted over the type of bins provided. Proposed by Councillor Finch and seconded by Councillor Brumby - **It was resolved that the Clerk ask North Lincolnshire to move the bin at the top of Hollingsworth Lane to Fieldside (next to the footpath on the school side between 57 & 81 Fieldside) - subject to it still being serviced, and up to a cost of £220 + VAT.**

(ii) **Dog Waste Bin** - At a meeting of the General Purposes Committee held on Wednesday, 23rd March 2022, it discussed the dog waste bin which has been removed from the field end of the footpath leading from Eastfield Road to the rear of Lockwood Bank and recommended it be reinstated. Proposed by Councillor Finch and seconded by Councillor Garner - **It was resolved that Full Council should agree with the recommendation made by the Combined Cemetery & Environment Committee and the Clerk send a letter to North Lincolnshire Council asking them to re-instate the dog waste bin.**

Hedges

At a meeting of the General Purposes Committee held on Wednesday, 23rd March 2022, it discussed the need to replace some of the hedging at the cemetery, however it was felt that there was a need to temporarily fill the gap in the hedge. Proposed by Councillor Brumby and seconded by Councillor Finch - **It was resolved that Full Council should agree with the recommendation made by the Combined Cemetery & Environment Committee and the Clerk be allowed to purchase some stakes and wire up to the value of £50 + VAT in order to fill the gap in the hedge at the cemetery.**

At a meeting of the General Purposes Committee held on Wednesday, 23rd March 2022, it discussed the need for more gravel for the cemetery paths. Proposed by Councillor R Whittaker and seconded by Councillor Garner - **It was resolved that Full Council should agree with the recommendation made by the Combined Cemetery & Environment Committee and the Clerk should purchase three tonnes of gravel from Axholme Landscapes at a cost of £150 + VAT for the cemetery paths.**

 The Clerk had been provided with a quote from Richard Dixon of Public Sector Audit, who carried out the internal audit last year. He said it was difficult to estimate in advance the time required and therefore what the cost would be for the 2021 / 2022 audit, however he estimated it to be in the region of £800. Proposed by Councillor Finch and seconded by Councillor Garner - **It was resolved that Public Sector Audit be asked to carry out the Internal Audit for 2021 / 2022 at a cost of up to £800.**
- 18/04/22** **Dementia Training**
 The Clerk had been liaising with others to try and arrange some dementia training, however there may be a need for somewhere more central and easier to park than Cemetery Lodge. **It was resolved that the Clerk should book the Small Room of the Imperial Hall on Wednesday, 18th May 2022, from 7.00 pm to 9.00 pm, at a cost of up to £10 for Dementia Training.**
- 19/04/22** **Best Kept Village Competition**
 The Clerk had received information about this year's competition and it was felt the Council should enter it - including the categories for Best Kept Playground / Best Kept Churchyard / Cemetery, Best Community Planting. Proposed by Councillor Brumby and seconded by Councillor R Whittaker - **It was resolved that the Council should enter the Best Kept Village Competition for 2022 at a cost of £50.**
- 20/04/22** **Items Raised by Councillors**
- (i) **Mayor** - This item had been deferred from the last meeting, because it was felt more councillors should be present to take part in such a decision. Some councillors believed it would be a good thing for Epworth because it would raise the profile of the town, however other councillors believed it was a status thing and you could do whatever you wanted to do as Mayor as Chair of the Council. Proposed by Councillor Woods and seconded by Councillor Garner that Epworth should have a Mayor. **The motion failed.**
- (ii) **Communication** - The Chairman stated that the Council had stopped publishing the Epworth Echo about a year ago and now relied on Facebook to communicate with residents. He had analysed the statistics and provided councillors with a copy of them. It showed that Facebook was only reaching the younger age groups and very few over the age of 65. Facebook should not be stopped, however it was nowhere near good enough and there may be a need to go back to a newsletter. Proposed by Councillor Garner and seconded by Councillor Brumby - **It was resolved that the Council should look at other ways of improving communication.**
